# eCommittee Regional Digital Accessibility Training for Court Staff with Visual Disability

Making the digital infrastructure of the judicial system more accessible to persons with disabilities is one of the core objectives of the e-Committee of the Supreme Court of India, being executed under the guidance of the Chief Justice of India, Hon'ble Dr. Justice D.Y. Chandrachud. Three training programmes of two days each were organised in the month of September, 2023 by the eCommittee, Supreme Court in collaboration with Delhi Judicial Academy for Court Staff with Visual Disability from Courts of all Northern States. A hands-on training model was adopted where each participant was given a desktop having accessibility software. The training was led by special educators from the National Institute for the Empowerment of Persons with Visual Disabilities using various assistive technologies. This training is a step in breaking down

disability barriers and in promoting inclusion and diversity to ensure that no Court Staff is excluded from accessing information and services.

# Overview

A total of 34 training programmes were conducted by the Delhi Judicial Academy from July to September 2023. Of the total programmes, 22 programmes were organised for judicial officers and 12 programmes were held for other stakeholders of the justice delivery system. The programmes, though mostly held physically in the Delhi Judicial Academy Complex, also had a mix of hybrid sessions where felt essential.

explained the working of the Legal Aid mechanism and how law graduates, irrespective of whether they intend to work in a law firm, to teach, be in public service, or in practice, can forward the goal of access to justice. Lastly, Ms. Pinky Anand and Ms. Rebacca John, Senior Advocates, explained their own journey in the legal profession and underscored that in the legal profession the pursuit of knowledge never ends.

A two day online workshop was organised for 120 law graduates in collaboration with the National Law University, Delhi. This collaborative workshop was held on 15<sup>th</sup> and 16<sup>th</sup> September, 2023 through video conferencing. The prefatory session was addressed by Hon'ble Ms. Justice Gita Mittal, Former Chief Justice, High Court of Jammu and Kashmir and Hon'ble Mr. Justice S. Muralidhar, Former Chief Justice, High Court of Odisha. They discussion focused on the role that the new entrants can play in the legal profession by upholding the constitutional vision of justice and protecting the rights of the people. Another session focused on the intersection of law and technology and how to maintain fairness and equity with the advent of new technology such as Artificial Intelligence, Machine Learning etc as well as the required skill set to be honed, so as to utilise technology to our advantage while furthering the cause of justice. Options beyond litigation were also explored. Dr Amit George and Mr Jonathan Fernandes explained the implications of ADRs. The intricacies of court craft, conduct and ethics were beautifully interwoven by both Dr Aman Hingorani and Mr Jayant Bhatt. Hon'ble Ms. Justice Asha Menon, Former Judge, High Court of Delhi

# Workshop on Order Writing for Assistant Controllers of **Patents and Designs (ACPDs)**

A three day order writing workshop was organised for ACPDs from across India in the Delhi Judicial Academy from 24<sup>th</sup> July, 2023 to 26<sup>th</sup> June, 2023, in compliance of the Judgment dated 12.05.2023 of the High Court of Delhi in Case No. C.A. (COMM.IPD-PAT) 88/2022 titled Synthes GmbH v. Controller General of Patents, Designs and Trademarks and order dated 26.05.2023 in C.A. (COMM.IPD-PAT) 158/2022 titled Huhtamaki Ayi and Another v. Controller of Patents. Twenty five ACPDs physically attend the workshop in the Delhi Judicial Academy, whereas the remaining 313 ACPDs joined virtually. This order writing workshop was conducted in different fields such as electrical, mechanical, chemistry alongside biotechnology and computer science for the ACPDs. The sessions were interspersed with practical understanding of the law and techniques on how to write a well reasoned order. Participants were given case studies and asked to attempt writing orders in real time. The orders written were then discussed and analysed in depth by experts in the field such as former members, Intellectual Property Appellate Board, former Controller of Patents and Designs and eminent advocates.

# Training of 10 newly recruited Judicial Officers (Grade-III) of **Manipur Judicial Service**

Ten newly recruited judicial officers of Manipur Judicial Service visited the Delhi Judicial Academy from 1<sup>st</sup> to 10<sup>th</sup> August, 2023. As part of their training, they underwent two days institutional training at the Academy on topics of electronic evidence, cyber crimes, age inquiry under the Juvenile Justice Act and other procedural issues in Criminal Law. The officers also visited NALSA and DSLSA, the Mediation Centre and Family Courts in Dwarka Court Complex, Tihar Jail, Juvenile Justice Board-I, Children's Home, Vulnerable Witness Deposition Centre and SPYM. They spent a day touring the city visiting various important historical and culturally important heritage sites in the capital. To understand the nuances of

remand and bail and to observe court proceedings in Delhi District Courts, the officers visited Courts of Metropolitan Magistrates in Tis Hazari and Rohini Courts. Lastly, they visited Intelligence Fusion and Strategic Operations, Dwarka to get a practical look into the working of forensic science.

## **Orientation Course on the Mental Healthcare Act, 2017**

An Orientation Course on Mental Health was held on 28<sup>th</sup> July, 2023 for judicial officers, police officials as well as mental health professionals. The Programme comprised of sessions breaking down the concept of mental health and mental illness whilst along side shattering stereotypes that have been built up around mental illness. The training also focused on comprehending "capacity", both mental and legal, as envisaged under the UNCRPD. The finer nuances of Mental Healthcare Act, 2017, including the rights of persons with mental illness as enshrined in the Act along with the responsibilities of the



stakeholders, were discussed. Case studies under the Act were also discussed. The law on fitness to stand trial and the defence of insanity were deliberated upon.

Training Programmes in Compliance of Directions issued by the Hon'ble Supreme Court in Satender Kumar Antil v. Central Bureau of Investigation and Another, (2022) 10 SCC 51

As per directions of the Supreme Court in Satender Antil v. Central Bureau of Investigation and Another, (order dated 03.02.2023) training programmes were conducted by the Delhi Judicial Academy for all judicial officers in all District Courts of Delhi in the month of July 2023. The programme dealt with general principles, guidelines and mandatory directions issued regarding arrest, remand and bail by the Apex Court and the High Court of Delhi. The sessions were interactive in nature and invited reflections from the participants.

## Training for Special Court (NI Act)

In compliance of the directions passed by the Supreme Court in Suo Moto Writ (Criminal) No. 2 of 2020 titled *In Re. Expeditious Trial of Case under Section 138 NI Act, 1881*, a four weeks training programme was conducted through online mode using the CISCO WebEx Platform for a retired District Judge who was appointed to preside over a Special Court (NI Act) established for the purpose of the pilot study. The training was conducted from 7<sup>th</sup> July to 3<sup>rd</sup> August, 2023.

The training focused on the basics of law relating to dishonour of cheques. The penal consequences of dishonour of a cheque, parties to a complaint, summoning and appearance of the accused, serving substance of the accusation to an accused and other different stages of trial of cases under the NI Act were discussed. The officer was also made aware of the rules relating to functioning of the Digital NI Courts, practice directions relating to Courts dealing with NI Act and rules and directions relating to vulnerable witnesses.

Emphasis was also placed on enhancing core judicial skills such as order writing, judgment writing, using ADR as an effective tool for disposal of cases, docket management and court management.

# **Core Competence Conference**

#### for Special Judges (NDPS) and their Public Prosecutors

Two simultaneous programmes were conducted for Special Judges (NDPS) as well as Public Prosecutors

posted in the said Courts on 2<sup>nd</sup> September, 2023. The first session focused on access to justice which included responding to a vulnerable witness/person battling addiction and the resultant challenges concerning mental health of such persons capacity to stand trial. Their right to personal liberty and balancing it with the need for rehabilitation was discussed. Training imparted focused on building a nuanced understanding of the legal framework against drug trafficking, narcotics, investigative process, including issues relating to investigation, trial, bail and sentencing. In addition, the programme for Public Prosecutors focused on recording and appreciation of evidence.



Hon'ble Mr. Justice S. Nagamuthu, Former Judge, High Court of Madras along with Mr. Reetesh Singh District Judge (Commercial Court), Shahdara, Karkardooma Courts addressed the judicial officers and public prosecutors in a joint session on the principles of sentencing on 2<sup>nd</sup> September, 2023

#### For Presiding Officers, Labour Courts and Industrial Tribunals

Presiding Officers of Labour Courts and Industrial Tribunals underwent a one day training programme on 1<sup>st</sup> September, 2023. The first session was organised as a Question-Answer session and dealt with the basic concepts under the Industrial Disputes Act, 1947. The following sessions dealt with adjudication of an industrial dispute related to domestic enquiries, execution of award and memorandum of settlement. Unfair labour practices vis-a-vis contract labour were discussed. The Programme concluded with screening of a movie highlighting the working conditions of labourers in factories.

#### For Presiding Officers, MACT, Police Officers and Nodal Insurance Officers

Core Competence Conference for Knowledge, Skill and Perspective development for Presiding Officers (MACT) and a Workshop for Building Synergy between different stakeholders were organised on 15<sup>th</sup> and 16<sup>th</sup> September, 2023 respectively. Training was held for the above mentioned officers as per directions passed by the Supreme Court in *Bajaj Allianz General Insurance Company Private Limited* v. *Union of India*, Writ Petition (Civil) No. 534/2020, vide order dated 16.11.2021. Training focused on conceptual issues of negligence, *res ipsa loquitur* and contributory negligence, and procedural issues such as jurisdiction, limitation etc. The recent developments

and its consequent effect on the role of the police, insurers and MACTs were delved into. Lastly, role of mediation and victim compensation by DLSAs as well as Lok Adalats was highlighted along with an understanding of the insurer's perspective. 'Rainmaker', the movie was shown to all participants.

#### For Special Judges (CBI) and their Public Prosecutors

A one day training programme was organised on 23<sup>rd</sup> September, 2023 for Special Judges (CBI). The Sessions focused on issues of procedure such as sanction for prosecution, bail, attachment of property, framing of charge and joinder of charge and trial. The new *modus operandi*, issues of investigation, evidence and other issues of trial were discussed for the new emerging trends in frauds and scams as well as for cases of disproportionate assets and trap cases. A simultaneous programme was also organised for

public prosecutors attached to these courts. In addition to the above, issues of remand, bail and the role of the Public Prosecutor in securing a speedy trial were also discussed with them. The art of examination of a witness and how to deal with hostile witnesses was delved into. The type of questions which can and cannot be permitted when recording evidence were discussed.

### For CMMs/ACMMs/MMs and their Public Prosecutors



Two programmes were conducted for one third strength of CMMs, ACMMs and Magistrates as well as Public Prosecutors on 21<sup>st</sup> July, 2023. The opening session was chaired by Hon'ble Mr. Justice Talwant Singh, Former Judge, High Court of Delhi who analysed the principles of remand and bail, the right to personal liberty and its interface with the constitutional vision. Access to justice and responding to a vulnerable witness was deliberated upon. The sessions also looked at issues faced by the Magistrates at all stages of trial. Handling of miscellaneous applications as well as safeguards to be kept in mind while

recording statements under section 164 Cr.P.C were also deliberated upon. For the Public Prosecutors, sessions also covered considerations to be kept in mind while perusing a police report as well as the art of examining a witness. Directions passed in the cases such as *Raj Kumar @ Suman v. State (NCT of Delhi)* and *Satender Kumar Antil v. Central Bureau of Investigation*, were also discussed with the participants. An exhibition showcasing arms and ammunitions was also organised for the participants.

# Fortifying Child Rights & Strengthening the Juvenile Justice System

An Orientation Course on the functioning of the Juvenile Justice Board and a Conference for Capacity Building for other functionaries of the Juvenile Justice System were held through video conferencing on 15<sup>th</sup> July, 2023. The programmes centred on coordination, enhancement of knowledge and development of rights perspectives of members and Chairperson of the Child Welfare Committees (CWCs), Officers of the Special Juvenile Police Unit, Member Social Workers and Principal Magistrates of Juvenile Justice Boards (JJBs), District Child Protection Units and Children's Courts. The issue of preliminary assessment of CCL in cases of Heinous Offences and the procedure to be followed therein was discussed. Functions of Children's Court, Juvenile Justice Board, District Child Protection Unit and Special Juvenile Protection Unit as under the Juvenile Justice Act, 2015 were discussed. Issues concerning Test Identification Parade, legal aid, medical examination including directions under *Sr. Sephy v. Central Board of Investigation*, 2023 SCC OnLine Del 717 were discussed. Core provisions of the Juvenile Justice law, specifically concerning grant of bail and appreciation of evidence, were focused on. The last session, which was a convergence session, facilitated dialogue and meaningful interaction between participants of both training programmes on the right stage of intervention, methods of communication, kinds of intervention whether therapeutic or social as well as rehabilitation in cases of drug abuse.

### **Programmes Catering to Police Personnel**

Inquiry under Section 107 and 151 Code of Criminal Procedure: Special Executive Magistrates

A three day training programme was conducted from 19<sup>th</sup> to 21<sup>st</sup> September, 2023 in compliance of the judgment of the Delhi High Court in Aldanish Rein v. State of NCT of Delhi and Anr., W.P. (Crl). No. 2039 of 2018 dated 01.11.2018. The Special Executive Magistrates were trained on the constitutional requirements of their roles. Detailed discussions were held on the implementation of Section 107 and Section 151, Cr.P.C. Mock order writing sessions and role play were conducted for hands on training. The participants were also shown a movie titled "Sirf Ek Banda Kafi Hai".

Sensitisation of Investigation Officers in handling investigation of cases pertaining to Human Trafficking and Sexual Offences against Women and Children

A two day Conference to sensitise investigating officers in handling investigation of cases pertaining to Human Trafficking and sexual offences against women and children was conducted for additional DCPs and ACPs in Delhi Judicial Academy on 24th and 25<sup>th</sup> July, 2023. The programme commenced by giving the participants a nuanced understanding as to what constitutes violence and how it adversely affects women and children more than anyone else. There was then a focused discussion on what constitutes Human Trafficking. The focus of the session was on trafficking in

the digital age. It was also felt important to underscore the victim's well being and the psychological impact both short term and long term, that a victim faces. A clinical psychologist discussed the different forms of impact that have been seen in victims, with the participants. The second day focused primarily on the legal matrix covering the issue as well as discussing the procedural issues faced by the police personnel while investigating and navigating the court machinery. Their role in rehabilitation was discussed and emphasised in the last session.

# Training of Trainers on Core Administrative functions and Management of Records

A programme for training two *Ahlmads* and one Reader from each district as trainers on administration and management of records was held on 18<sup>th</sup> July, 2023. The aim of the programme was to build capacity and improve engagement amongst the court staff on issues related to general conduct and behaviour, an understanding of their core duties and functions, creation and inspection of record both in civil and criminal courts and how to deal with loss of record and eventual weeding out of record.

# Sensitisation Programme for High Court Staff on Public Dealing



A Sensitisation programme for High Court Staff on Public dealing was held on 22<sup>nd</sup> July, 2023 for 44 staff personnel deployed at the Filing Counter/ Pass Counter/ Facilitation/ Help Desk/ EPABX of the High Court of Delhi. The session began with a discussion on how one should conduct themselves in public– the appropriate dress code as well as do's and don'ts. Research Wing of the Delhi Judicial Academy conducted a public survey through a questionnaire in order to understand the difficulties faced by the litigants while dealing with the registry, results of which were shared with the participants. Necessary sensitivity, that is required to be maintained while

dealing with persons belonging to marginalised sections, was also discussed. A session was held specifically on how to handle grievances including how to give a patient hearing to a litigant and the essential communication skills. Further the programme delved into an overview of the Citizen's Charter and preparation of a checklist for those present after discussion and identification of best practices. Best practices were discussed to ensure minimisation of difficulties faced by the litigants, lawyers and general public. Lastly, participants learnt yoga exercises and pranayam to cope better with their job stress.
